MAYOR READS HIS ANNUAL MESSAGE

Good Morning!

Welcome to the 120 re-organization of the Wallington Governing Body.

I am blessed with the honor of serving as your Mayor as I begin my 24th year this year.

I extend my best wishes to everyone for a happy and healthy New Year!

Congratulations to Councilman Roman Kruk on his reelection and to newly elected Councilwoman Sharon Robie.

Roman's father Joseph and Sharon's father Thomas Bartlo are proudly looking down on them today.

Over 2 miles of new 8 inch ductile water mains have been installed replacing 100 year old 3 and 4 inch iron metal lines.

New copper service lines to each house has also been installed replacing aging galvanized metal lines.

Over 5 miles of new plastic gas lines are being installed by Public Service.

It was necessary to replace these rusting lines to convert our low pressure gas service to high pressure.

The low pressure system had to be converted due to the flooding we experienced causing thousands of dollars of damage to gas furnaces and gas hot water heaters, due to flood waters infiltrating the old iron gas distribution pipes.

Our entire community looks like a construction site!

Upon completion of this installation all road ways will be re-milled and re-paved.

The addition of a new supermarket which is anticipated to open by Memorial Day is a welcome addition to our community.

Our shared services agreement with the Bergen County Sheriff's Department for K-9 training at the Latex site is working well. A Graduation Ceremony will be held at this Civic Center on June 22, 2015.

Our Police Department under the leadership of our Chief Carmello Imbruglia is updating policing procedures and new training programs in order to have our Police Department accredited.

We are in the process of foreclosing on the Garfield molding property located at 1 Midland Avenue for non-payment of taxes and water bills.

The owners have two more weeks to pay approximately \$500,000.00 before the property is owned by the Borough of Wallington.

Wallington was inundated with tax appeals in 2012 and 2013which prompted a re-evaluation of all properties.

Most property value was placed on the non-flood prone areas creating an increase tax burden on these properties.

In order to stabilize taxes we have to seek new ratable.

The closing of Farmland Dairies has created a serious impact on our community. With the loss of this tax ratable I am forming a Committee Vision 20/20 to develop a plan for this area.

This Committee will meet at the Civic Center at 7:30PM on the second Tuesday of each month commencing on February 10th 2015 and will be advertised as a public meeting.
